2013/6430	CONDITION OF STOCK	RESUME
	The Head Agister told the Court that the weather is not on our side. It was very wet, and now it is cold and wet. The condition of ponies has dropped off significantly in the past couple of weeks and the Agisters are already removing animals from the Forest. Mares with foals have been the first to lose condition, followed swiftly by some young ponies.	
	Having said that, the overall condition of stock remains good. A lot of animals look fine.	
	The Forestry Commission is cutting holly but the Court felt that if more could be done it would be extremely beneficial to the ponies in particular. The Official Verderer had noticed cut holly on Fritham Plain and also some has been cut at Holmsley. Mr Deakin said he is going to raise holly cutting with the Forestry Commission later in the meeting.	

2013/6431 STOCK LOSING CONDITION AND REMOVED FROM THE FOREST RESUME

ANNOUNCEMENTS AND DECISIONS BY THE OFFICIAL VERDERER

2013/6438 VERDERERS HALL PA SYSTEM

Following complaints that those of you sitting at the back of the Court were having problems hearing presentments, we have adjusted the public address system and I hope that you are now able to hear everything clearly. If not, please let us know!

2013/6439 SHEEP ON THE COMMONS

At the November Court, Mr Geordie Cook again raised the issue of sheep which he believes should not be depastured on the Forest or commons. The Verderers discussed this at both November's and December's committee meetings.

The Court has considered Mr Cook's various presentments very carefully and the paper he produced at the last Court (a list of animals turned out in the past) was also scrutinised. The position is not, however, black and white. It is clear that the Forestry Commission, for whatever reason, did not record any rights over the commons except Pasture – being the right to turn out ponies, cattle and donkeys. Formal confirmation of whether or not sheep rights exist over the National Trust Commons does not exist and as a result the National Trust has chosen to permit sheep to be depastured on its commons in the north of the Forest.

The issue of sheep remains a grey area and the Court is currently of the opinion that it is not on firm ground and therefore any attempt to remove the sheep would quite possibly fail. It was felt the status quo should be allowed to continue.

2013/6440 MAXIMUM AGE FOR ELECTED VERDERERS

In November, Mr Cook suggested that Miss Macnair was not allowed to serve as an elected Verderer because of her age. I have researched this issue and I found no grounds to indicate that there is a maximum age for an elected Verderer.

2013/6441 VERDERERS' GRAZING SCHEME

In November, I announced that we have set the grazing payment value of £100 for one livestock unit.

So the following values will be used to calculate payments to Crown Land commoners:

Cattle £100
Registered pure bred New Forest ponies £80
Other equines £40
Pigs £30
There is a maximum payment of £6,000.

Grazing payments will be made to Crown Land commoners by electronic bank transfer towards the end of February.

At a recent meeting of the Verderers' Grazing Scheme Advisory Group, the National Trust, Natural England and the CDA reached consensus about a possible solution for grazing payments on the adjacent commons with associated conditions. This will be considered

later today in committee and next week by the Verderers' Grazing Scheme Management Committee. I will report to you next month what is decided. If possible, we would like to make payment to those who graze the adjacent commons and the Crown land commoners at the same time, towards the end of February.

May I please remind all commoners that the pot of money will now be fixed at the total based on the current turn-out at these Livestock Unit payment rates. If the total number of animals depastured increases the pot won't increase and so the result will be a pro-rata decrease in the value of the Livestock Unit, so commoners will receive less grazing payment per animal. This is designed to stop a huge increase in animals turned out simply to claim the subsidy.

ANIMAL ACCIDENT REPORT

2013/6442 THE ANIMAL ACCIDENT REPORT FOR 2012

An initial analysis of animal accidents reported during 2012 shows that the accident rate is probably the lowest since records began

- 65 deaths (almost identical to last two years) (2010: 65, 2011: 66)
 - 52 ponies, 7 cattle, 6 donkeys died
- 18 injured – only in 2003 was it less than this (16). (2010: 27, 2011: 36)
 - 13 ponies, 5 cattle were injured
- 83 killed and injured – nine less than the previous lowest total in 2010.
- 137 accidents in total – we think this is lower than ever before

There was however a massive preponderance of night-time accidents this year: 119 of the 137 accidents – the messages are therefore watch out at night / go slowly when passing other traffic with their headlights on / look for collars and look for ponies without collars.

That said, 13 accidents occurred in daylight where there can surely be little excuse.

As usual most of the vehicles involved were cars or light commercials. 106. No HGV's collided with commoners' animals last year but we had 2 accidents involving motorcycles and 1 involving a tractor.

59 of the motorists were local which means they live in the Forest or in the towns and villages on the Forest's border. 23 accidents were not reported. This number is of course still too high.

ANIMAL ACCIDENT REPORT FOR DECEMBER 2012

In December there was also a welcome reduction in the number of accidents compared with the previous year.

However, the Agisters still attended 10 accidents, all involving ponies. This was less than half the previous December when 24 accidents were reported.

Only one driver was local.

6 ponies were killed, 2 of which were foals, and 1 pony was injured and had to be destroyed. None were wearing collars.

2 ponies were uninjured and 1 which was reportedly involved in an accident could not be found.

9 cars or light commercials were involved. 1 driver have failed to report the accident.

That accident occurred on the 1st December when a foal was found dead at lunchtime on the B3078 at Howen Bottom.

Accidents occurred on the road between Longslade and Setthorns campsite, at Sway on the railway bridge and at Hatchet Pond. Also between Marlpit Oak and Setley, outside Burley School, at Latchmoor and at Claypits, which like, Howen Bottom is on the B3078.

The Official Verderer thanked the Clerk for all her hard work relating to the reduction of animal accidents. He stated that although it is pleasing that accidents appeared to be at an all-time low, the Verderers will continue to campaign for an ultimate goal of zero animal accidents.

2013/6443 COMMONING

Presentment by Mrs Mary Gray, Commoning Family at Brook

'Twenty years ago a Mr Allen, past Captain of Bramshaw Golf Club, started the ball rolling concerning our cattle leaving and returning from our holding, parallel to the first fairway on the Forest Course (Brook Common), 'Burn Fuzzen' as my late father called it!

Remembering our animals have a right to do this!! Not on licence, as the Golf Club are.

This could go on being discussed until 'the cows come home' excuse the pun.

The point I am making today, at Open Court, for our future generations to know, 'do commoners legally turned out stock, have support from the Official Verderer, the commoners' Elected Verderers, Natural England also Forestry Commission representatives, not forgetting National Park' OR will recreation and other interests become priority over commoners' rights on Open Forest in general.

This could be a devastating effect on the house-keeping of our Open Forest. A more economical, friendly, natural way of architecting God's good green land, could not be equalled.

Pointing out to Mr Allen in 1993, 'Take a look over gate, come spring, nature will do its job, with a little self help'.

Blessed with more kind seasonal weather, this of course is not in our hands! Thank you.'

2013/6444 SHEEP

Presentment by Mr Geordie Cook

Mr Cook returned to the Court to again raise the grazing of sheep on the commons. He produced a map, which he said he had taken into the office, which he said shows the rights but said there are no rights for sheep.

He then accused two Verderers of laughing at him last time he attended Court, and he complained that the Official Verderer had also been disrespectful by asking him for clarification.

Mr Cook then repeated his claim that Miss Macnair is too old to be a Verderer.

Mr Cook said he would not return to the Court again to raise the issue of sheep

In response, the Official Verderer said that we live in a democracy and so Mr Cook is entitled to come to Court and to voice his opinion. The fact is, however, that although sheep rights were not officially recorded in 1964, they have been grazing the National Trust commons, with the agreement of the National Trust for many years. It is unlikely that an attempt to remove the sheep would succeed and the Court has decided that the status-quo should be allowed to continue.

2013/6445 AGE LIMIT FOR VERDERERS RESUME

2013/6446 COMMONERS RESUME
Presentment by Mrs Mary Gray

The advantages and disadvantages of feeding cattle on the Forest versus cattle coming home each day to be fed were considered in detail.

The Court agreed that there should be no doubt that it supports commoning.

From time to time there will inevitably be conflicts between commoners and other Forest users and recreational activities and facilities.

Receiving payment for depasturing stock brings with it a responsibility for ensuring stock are properly managed so as to cause the least possible damage to the Forest. Payment is made for good practice. That said, in wet weather it is inevitable that some damage will occur and then it becomes a question of what is and what is not acceptable.

Commoners do not have a 'right' to put out supplementary feed for their animals and feeding on the Crown Lands must be agreed with the Forestry Commission, Natural England and the Verderers.

There is a long standing conflict between the Gray family's commoning activities and the adjacent golf course which has never been satisfactorily resolved. Further efforts are being made in this respect and a further site meeting is likely to be required. Mr Street said that the golf course license and therefore its layout predates the gate. The gate was put in as a result of increased traffic which made turning animals out of the main farm gate onto the road too hazardous. Action DW

Mrs Westerhoff explained that the golf course was, in the past, considered to be in unfavourable condition for an SSSI. As a result, certain works were carried out to try to bring the land into favourable condition. It was suggested that some of those works which included infilling some drains may have created wetter ground which has perhaps contributed to the increased poaching.

Mrs Westerhoff said she would be happy to visit the site with a view to making sure that the golf course management plan is being adhered to if Natural England and the Forestry Commission would like her involvement. If the plan is not working it may need to be reconsidered.

The Official Verderer suggested that the size of the RLR parcel needs to be confirmed and the percentage which is poached calculated to see if it meets or exceeds HLS criteria.

The Court clearly supports commoning but it was agreed that the payment of subsidy for grazing brings responsibilities. The money which is paid to commoners under the HLS/VGS is for conservation, not damage. The number of animals turned out from this particular holding in 2012 increased threefold and this will have exacerbated the poaching.

2013/6448 JUBILEE OAK AT BLOOD OAKS GREEN, BRAMSHAW

DISCHARGE

Whilst it is not normally the Court's policy to agree the planting of commemorative trees, the planting of a commemorative oak on Blood Oaks green is agreed as it is understood the new tree is a replacement for an existing landmark tree which is (relatively speaking) nearing the end of its life.

The consent is subject to the approval of Natural England and is also conditional on agreement that the protective fencing, which will consist of a post and rail enclosure approximately 2.5m square, will be properly maintained for as long as necessary so as not to become dilapidated and a hazard to depastured stock.

2013/6449 PUBLIC SAFETY ON DRIFTS

The Official Verderer requested that the Forestry Commission closes car parks and cycle route in the vicinity for the duration of a drift in order to maintain public safety.

The Deputy Surveyor welcomed the Court's review of the management of the drifts. He confirmed the Forestry Commission is happy to work with the Court 'in principle' to ensure the safety of the general public as well as

those who are actually involved in the drifts. He suggested a risk-based approach.

The Deputy Surveyor is tasking Mr Simon Smith from the Forestry Commission's Recreation department to review this with Mr Deakin and the Head Agister.

The ditching work at Hilltop is welcome and considered to be a job well done. However, there are two places where someone appears to be deliberately driving over the newly constructed bank. There is another place close to the public house where the ditch stops and vehicles can still park. The Deputy Surveyor said these matters will be attended to.

Unfortunately some people are now parking in front of the barriers but it was reported that Hampshire County Council's Community Safety Officer has recently spent some time at Hilltop placing stickers on cars and moving on parked vehicles.

2013/6454 RHODODENDRONS IN BURLEY DISCHARGE

The Estates Keeper Mr Graham Wilson has met with Miss Macnair and the problem rhododendrons have been identified. The cutting back is in the work programme and will be done as soon as possible.

SSSI RESTORATION WORKS

2013/6462 SITE VISITS DISCHARGE

The Deputy Surveyor said site visits have been temporarily suspended due to staff shortages. Two short-term appointments are being made in order to progress matters. A tender for a planning consultant is also being issued as the National Park Authority now requires a formal planning application for any significant engineering works on the Forest. The Forestry Commission does not possess that expertise which will now have to be 'bought-in' at considerable cost. Unfortunately the result will be less funding being available for actual work on the ground.

2013/6463 SNAGGING LIST RESUME

An updated snagging list was provided.

Mr Pasmore requested several further items be added to the list as follows:-

Sluffers stream restoration work: the upper section of the ramp down from the filling to the unaltered stream has virtually washed out leaving the risk of further rapid erosion and a tangle of binder twine which is a hazard to stock.

High tree stumps have been left in Sluffers – some 18" above the ground. These need to be reduced.

Lower Crockford Bottom – a quantity of cut Scots Pine has been left.

The Deputy Surveyor said he will add these items to the snagging list for action as soon as ground conditions permit.

2013/6469 DEFRA/BCMS CATTLE MOVEMENTS BETWEEN HOLDINGS DISCHARGE

Mr Draper (VGS Manager) and the Head Agister attended a recent meeting.

All cattle will in future be on one year testing schedules. Linked holdings will no longer be permitted. However if land has rights over the same common it will not be necessary to TB test cattle each time they are moved between parcels of such land. The New Forest is one common.

2013/6470 AGGRESSIVE PIGS DISCHARGE

Several reports have been received of aggressive pigs on the northern commons. A number of horse riders have reported being 'chased' by pigs.

Two Agisters have ridden their own horses in the area but have not encountered any problems.

It is thought that the pigs may be in-season sows which will sometimes show an interest in other animals including horses and ponies.

Many horses and their riders dislike pigs and the Court agreed that a pig cannot be removed without sufficient evidence. Pigs are one of the natural hazards that horse riders must be prepared to negotiate if they wish to ride on the Open Forest.

It was agreed that there is nothing further to be done at present.
