2011/5474 MINUTES OF THE LAST MEETING RESUME

The Minutes of the Court held on Wednesday, 20th April 2011 were approved.

2011/5475 CONDITION OF STOCK & THE WELFARE TOUR RESUME
(see also 2011/5509)

The Head Agister reported that since the last Court the Welfare Tour has taken place. It was very well attended and very successful. A large number of animals were seen and virtually all the comments received were positive. Those present were pleased with the overall condition of the animals that they saw. Representatives of the welfare organisations attending also said that they have had few complaints from the public through the winter.

There are a lot of foals on the Forest now and some of the mares, particularly those which have just foaled, do not look as well as they might. Anything that gives cause for concern will be removed.

As reported in the April Court, a few cattle have been taken off the Forest because their condition was not satisfactory.

Most animals are now starting to put on condition as the grass is beginning to grow. The dry weather is not, however, helping although where burning has been carried out, the grass is growing well.

The Forestry Commission had a successful burning season and completed most of the planned program.

The Head Agister left the meeting.

Mr Deakin remarked that on the welfare tour the only complaint received was that a few ponies have long feet.

A few complaints have been received about poor cattle as reported at the last Court. The problem appears to be that commoners have run low on

fodder and have turned their cattle out a little too early. Any that are too poor will be removed as there is not a lot of food on the Forest yet for cattle.

Mr Deakin said the Staff Committee may decide to come back to the Court over the question of whether any action is required in respect of owners of stock which is turned out too early.

RESUME

The Official Verderer said he visited the site the day before the Court with Mr Street from the Forestry Commission. He has also introduced himself to the Court's solicitor and has discussed the case briefly with him.

A letter has now been received from the solicitor acting for the owner of Home Farm asking for a site meeting to be attended by both sides together with their lawyers. It was agreed that if a resolution is reached, a hand written record should be made at the time which would be signed by all those present. If no agreement is reached, the matter would then have to be referred to the Courts.

Mr Pasmore expressed his reservation that this would mean that the Verderers who attend will make a decision without the approval of the full Court.

Mr Deakin then asked if the Verderers attending could be given a mandate to make a decision on this one occasion.

The Official Verderer said the advice he has received is that new rules for alternate dispute resolution have recently been introduced. Failure to follow the rules is looked at in an unfavourable light by the Courts. For this reason, he felt the meeting, as requested, should be held, as this clearly indicates a willingness on the part of the Verderers to resolve the issue out of Court if at all possible.

At this point, the discussion was halted. It was resumed later in the meeting (before Minute No. 2011/5509) and continued as follows:-

The Commoners' Defence Association is paying 50% of the cost of these proceedings, therefore it's approval must be obtained prior to a settlement being agreed or further costs being incurred. The Chairman of the CDA, Mr Graham Ferris, should also be asked to attend the meeting.

ANNOUNCEMENTS AND DECISIONS BY THE OFFICIAL VERDERER

2011/5483 MR JEFF KITCHER MBE

It is with great regret that I have to report the death of elected Verderer, Mr Jeff Kitcher MBE, on Monday 9th May. Jeff served this Court for just under 23 years. He was awarded an MBE in 2003 for services to the Forest and commoning. His very valuable contribution to the proceedings of this court will be greatly missed. Personally I always found Jeff to be gentle, amusing, generous with his time, knowledgeable and helpful. We offer our sincerest condolences to his family. Jeff's funeral will be held next Tuesday, the 24th May at 10.30 a.m. in Beaulieu Abbey.

May I ask Elected Verderer Mr Richard Deakin to now give a fuller tribute...

JEFFERY KITCHER

68 years ago, on 3rd January 1943 Jeffery Kitcher was born. (Jeffery, Jeff, 'Kitch').

One of three children, he had two older sisters, one of which survives him, he grew up in Okedene the family home at Furzey Lodge, Beaulieu. Attending school at Beaulieu and Brockenhurst. He lived most of his life in Okedene, with just a few years spent in a bungalow 200 yards up the road. You could say that his roots were nearly as deep and fixed as the trees that he eventually came to work with. He saw no good reason to go away on holiday.

Upon leaving school he started work on Beaulieu Estate. His self employed father wanted more security for him and he advised joining Beaulieu Estate rather than The Forestry Commission as he didn't trust the Commission to look after his long term future. I don't know if things changed in this regard, but in the early 60's, Jeff moved, actually taking employment with the Forestry Commission. For some time he worked with his father who was a contractor to the FC, pulling out timber with heavy horses. It is believed that Jeff was probably the last person to use Horses in this work. He always thought that current day examples appear to be "just playing at it". Saying he could pull more himself without the horse.

Jeff then trained to operate the various new machines that were phased in to modernise Forestry Operations, and continued to drive these until deciding to leave the FC in 1983 and start his own Forestry Contracting business. He completed 20 years with the FC. He continued to run his business until his untimely death, which was beyond normal retirement age, saying that he didn't see much sense in retiring as he felt that to continue to enjoy life he would carry on doing exactly the same things as when working, despite being retired. What a fortunate position to find yourself in!

As well as pursuing a busy career, in the 70's, his deep love and commitment to The Forest and to Commoning led him become a founder member of The New Forest Stallion Syndicate, a group set up to help ensure that there was a sufficient number of stallions available to run The Forest and also to act as a pressure group actively working for the interests of the Commoner. He also joined The NFCDA committee, remaining there as a very active member for the rest of his life, and in latter years being elected as Association President. He successfully stood for election as a Verderer in November 1988, again remaining in position, through many elections, until his untimely death. During that time for two separate periods he filled the role of Staff Committee Chairman, a role that effectively

assumes control of and responsibility for the Agisters and their activities. He was a prime mover in establishing the Welfare tours that have been heralded as a significant step forward in depastured animals condition, and also the outside perception of welfare on the Forest. He was also a founder member of the New Forest Livestock Society, which was set up to raise funds to rebuild and operate the Beaulieu Road sale yard. I'm pleased that he was able to attend the last sale for a brief period.

In Committee he listened a lot and spoke less, but when he did speak he commanded respect, people listened and usually his words ended further debate. Appropriate recognition for his services to Forestry and Commoning came with the award of an MBE in 2003. An award he received with humility and pride. Jeff was a true believer in the (slightly modified) proverb : "We haven't inherited The Forest from our fathers, we have loaned it from our children". He was determined to hand it over in good order to the children that he had with former wife Phyllis and partner Christine. Four children; Natalie, Jacqueline, Paulette, and Kelly. Our own role in that demanding challenge suddenly got much harder on the 9th May, when we lost the ability to draw upon his enthusiasm, wisdom, expertise, and experience for help.

Our thoughts are with the immediate family, and also with the extended family and extensive network of friends and colleagues'.

Please be upstanding for a minute's silence in memory of Jeff Kitcher.

2011/5484 NEW OFFICIAL VERDERER

My name is Dominic May. I have the honour to have been appointed by Her Majesty the Queen to serve as Official Verderer for a term of three years. I will carry out my role as chairman of this court with vigour and independence. I will endeavour to ensure during my term of office that all decisions taken by the Verderers and the Verderers' Court will be to the benefit of the preservation of commoning and the conservation of the New Forest's unique landscape and character.

2011/5485 STALLION BLOODLINES SCHEME

Following the excellent response to our request for suitable mares to be offered for inclusion in our bloodlines scheme, 15 suitable mares have been selected. These mares will be visiting 5 specially selected stallions very soon. Only time will tell how successful the scheme turns out to be, but the hope is that it will result in several good colts.

2011/5486 DOGS

At our last Court, Mr Tarnoff suggested that details of serious dog attacks on Forest stock should be reported in Open Court at the same time as the Animal Accidents. We feel, however, that as few incidents are actually reported to our office, it would be preferable to only publicise the worst attacks.

A record of various types of incident is kept by the Forestry Commission in a database and dog attacks are included. The Forestry Commission's policy is that dogs must be kept under control at all times.

ANIMAL ACCIDENT REPORT

2011/5487 ACCIDENT REPORT FOR APRIL 2011 (amended)

The Agisters attended 10 accidents, compared with 5 in April last year.

2 ponies, 1 cow and 1 donkey were killed and 2 ponies and a cow were injured.

7 accidents occurred during the hours of darkness.

8 involved private cars or light commercials.

1 accident was not reported (hit and run).

5 accidents involved local motorists.

The total killed and injured for the year to date is 25 compared with 19 for the same period last year.

MR JEFFEREY KITCHER MBE

CDA members were shocked and saddened by news of Jeff Kitcher's passing and wish to join the Verderers in extending our condolences to all his family and many many friends and colleagues.

The essence of Jeff Kitcher, the man, was the essence of all that is important about the

New Forest. His strength was legendary, both his physical strength and strength of character. His fearless riding was never lessened by regular injuries and his colt catching abilities were called on even by experienced Commoners dealing with tricky animals. His memory of people, events and places in the New Forest was prodigious. His recall of incredible detail about past horses brought his much loved stories to life. His eye for the right type of pony to run on the Forest was unerring and his knowledge of the history of the Forest was detailed. His defence of the New Forest and of commoning was passionate. His generosity with possessions, but above all with time to help others was unselfish. His wisdom was widely recognised and respected. That wisdom came from a lifetime of service to the Forest and was rooted in hands on practical experience of work in the woods and of commoning.

It was a wisdom he wore lightly. Never forcing it on people in the spirit of "knowing better" but rather offering it in the hope that it might contribute to a better future for commoning and the Forest as a whole. And especially in the hope that it might guide future generations in their guardianship of the Forest.

Jeff accepted his MBE with modesty and if he were here now he would probably say something like "Well I don't know about all that that you've just said".

Jeff will be greatly missed by Commoners young and old, but his contribution over so many years to the life of the Forest and of commoning will be a lasting tribute.

NEW SUBMISSIONS AND OTHER MATTERS RAISED BY THE FORESTRY COMMISSION

2011/5490 SEMCORP BOURNEMOUTH WATER COMPANY PROPOSED WATER MAIN REPLACEMENT - TRIAL EXCAVATION AT FRITHAM DISCHARGE

The Court considered the water company's proposal to dig four trial holes in anticipation of a scheme to replace an existing water main in Fritham, which has been identified for replacement due to the high number of recent emergency repairs. The holes will establish both the exact position of their existing infrastructure and also establish the soil conditions. The latter will enable them to ascertain the best method that can be used to lay the replacement pipe. It is anticipated that a proposal for the entire scheme will be submitted for approval in advance of an autumn start date, subject to consent and Natural England's guidance.

A plan was provided illustrating the section of the scheme in the vicinity of the reservoir. The full scheme runs from Nomansland reservoir south to Fritham Lodge. Mr Street said he hopes that most of it will be laid in the highway or under the verge.

The proposal confirmed the trial holes will be carried out in accordance with the agreed working protocol with Natural England and no holes will be left open over night. The trial holes will be approximately 3m long by 1m wide and 1.5 m deep.

The Court considered and approved the proposals for the trial holes subject to the usual conditions regarding satisfactory reinstatement, safe working conditions, compensation for loss of grazing etc.

MATTERS ARISING OF CONCERN TO THE FORESTRY COMMISSION

- 2011/5491 DOGS DISCHARGE
- The Clerk explained that she intends to create and maintain a database in the Verderers' Office in which will be recorded details of incidents between dogs and Forest stock. The Verderers' Office database will include incidents across the whole Forest, i.e. including the added areas. The Forestry Commission will be advised of any incidents which occur on its land to ensure that its database is kept up to date. The CDA will be asked to let its members know that dog related incidents should be reported to the Verderers' Office. In response to a query regarding incidents involving horse-riders, it was agreed these should be reported to the Forestry Commission or the National Trust depending on where the incident occurred.
- 2011/5492 PUBLIC BODIES BILL RESUME
- The letter from the Rt Hon Jim Paice MP in response to Official Verderer Oliver Crosthwaite Eyre's earlier letter has now been received. A copy of the letter will be appended to these minutes. The letter states that all provisions relating to Forestry and the Forestry Commission have been removed from the Public Bodies Bill. The only power which remains is the power to abolish the Home Grown Timber Advisory Committee which has not met for over five years and is defunct. As such there are no bodies in the Bill that exercise forestry functions so the Government cannot envisage any circumstances in which the powers in the Bill would ever be used to change the New Forest Acts.

- The Panel met last week. It is at the information gathering stage. It has received lots of requests from organisations and areas of the country to visit. Mr Kevin Penfold was asked to ascertain whether the Independent Panel on Forestry will be visiting the Forest. Post meeting note: Mike Seddon has informed the Official Verderer that the panel will not be visiting New Forest, only the Forest of Dean, Northumberland and Kent.

- Mr Street reported that Mr Mike Seed of Hampshire Highways (HHW) is preparing plans identifying the location of all the bins which have been placed on Forestry Commission land in order that formal consent can be sought. The Clerk was asked to write a letter to Mr Seed to say that the grit bins must be removed immediately and if HHW would like to re-install them next winter and subsequent winters, permission from the Verderers must be sought each winter with a detailed site plan.

- 2011/5500 TRACK AT HOME FARM, BARTLEY RESUME
- During their recent site visit, Mr Street and the Official Verderer noted that the track to the property has been resurfaced without consent. Limestone has been used which is not permitted on the SSSI. This matter was raised last year but a decision has not been taken as to the next step. In addition there is evidence that an area of grass has been mowed which is not permitted. Mr Street will write to Ms Jenny Thomas at Natural England about these issues and he will ask for her comments as respects the use of the limestone. The Clerk was asked to find the reference to this matter and advise Mr Street.

- 2011/5501 BRIDGE AT MARKWAY DISCHARGE
- Capt Moore, former CDA Chairman, complained about a bridge between Clumbers and Ferny Knap, (renamed the Markway Crossing) which he regards as dangerous to horse riders. Mr Penfold confirmed that the bridge is moving up the list of outstanding works and will be looked at soon. The bridge may be replaced. The Clerk said she will write to Capt Moore to let him know the latest position.

- 2011/5502 RUBBISH ON OPEN FOREST OUTSIDE COMMONER'S HOLDING RESUME
- Miss Macnair raised the issue of a commoner's holding in the west of the Forest where various old vehicles, machinery and rolls of wire have been left outside the holding. The items are dangerous to stock and unsightly and the situation as it is at present is unacceptable. The Court agreed that consideration should be given to using the Verderers' Stewardship scheme as a lever to persuade the commoner to tidy up. The VGS Manager will, therefore, be asked to write to the commoner warning him that if the area outside his holding is not cleared up, the matter will be referred to the VGS Sub-Committee where consideration will be given as to whether to withhold all or some of his payment for this year. Mr Street and Mr Graham Wilson from the Forestry Commission will also visit the holding.

- 2011/5503 DUR HILL DISCHARGE
- Miss Macnair asked when the Forestry Commission intends to go back and clear up the brash at Dur Hill. She also asked if it was really necessary for the 'totem poles' to be left standing. A number of cut off trees' devoid of all branches or vegetation have apparently been left for the benefit of raptors. In response Mr Penfold replied that the site will be revisited in the autumn.
- 2011/5504 BUCKHERD BOTTOM DISCHARGE
- This area also has a quantity of brash left following felling work. Again, the plan is for further work to be carried out in the near future.

2011/5505 INSTALLATION OF STILES DISCHARGE

Mrs Thorne reported that Hampshire County Council has recently announced a desire to replace some stiles on public footpaths in Linwood with metal kissing gates. These gates are unsightly, out of character and considered to be dangerous to stock. In addition, small animals such as little pigs would have little problem negotiating them. It is believed the funding for the replacement of the stiles in other villages may have come from the National Park Authority. The Verderers consider such replacement undesirable in the New Forest and supported Mrs Thorne's concerns.

2011/5506 CONTROLLED BURNING DISCHARGE

The Court thanked the Forestry Commission for completing the burning programme this year. Burning attracts a lot of criticism from the public but its value was borne out by the comments made by representatives of the outside bodies on the Welfare Tour who remarked how well the grass grows after burning. This makes a very valuable contribution to the ability of the ponies in particular to come through the winter in good condition. Swiping leaves the cut material on the ground which prevents new grass, so is by no means as satisfactory.

2011/5507 LONG MEADOW RESUME

The New Forest Show Society has asked if they can use Long Meadow for overflow parking for the Show in July. In return the Show Society will lay on water and repair the fencing; works which the Forestry Commission will have problems finding the funds to carry out. The Show Society has also offered to supply water free of charge to the field whilst it is leased to the Verderers. Concerns were expressed however at this proposal, because by that time, the mares from the Bloodline Scheme will be in the field. It was agreed that the best way forward is for Mr Deakin to meet with Mr Street and the Show Society to discuss the issues.

2011/5508 STALLION SCHEME UPDATE DISCHARGE

21 stallions were released onto the Forest on Saturday (14th May). The press kindly issued a short editorial piece to advise the public that the stallions were being put out. The stallions must be off the Forest by Sunday 11th June.

2011/5509 WELFARE TOUR RESUME

Mr Deakin returned to the subject of the Welfare Tour. He said that there was a good turnout from the bodies invited to attend. Approximately 600 animals were seen. In the absence of an Official Verderer, Mr Deakin hosted the tour and asked for feedback when everyone had returned to the Verderers' Hall. One person said their organisation had received a suggestion that the Forest should be cleared of all stock that are poor. It was accepted, however, that this is impractical. The British Horse Society representative expressed concern at the number of obviously non New

Forest Ponies that are turned out. It was explained that the commoners breed what they can sell and of course in recent years, there has been a demand for coloured ponies.

The Clerk requested that a date for the next Welfare Tour be agreed at the next Court.
