# ANNOUNCEMENTS AND DECISIONS BY THE OFFICIAL VERDERER

### 2012/6331 ELECTED VERDERERS

The terms of office of Dionis Macnair and David Readhead come to end this month. Ordinarily there would have been an election. However with only two candidates for two places on the Court, both Dionis Macnair and David Readhead are elected unopposed and will serve for six years until 2018.

### 2012/6332 MARKING FEES

I am pleased to announce that due to a tight rein on costs and judicious housekeeping by the Verderers' Clerk, there will be no increase in marking fees for 2013.

# 2012/6333 VERDERERS GRAZING SCHEME

We are in the first year of the new Verderers Grazing Scheme, which commenced on 1<sup>st</sup> March. We have had terrific success, with 92% of the animals depastured on Crown Lands entered. We have now set the grazing payment value of £100 for 1 Livestock Unit.

So the following values will be used to calculate payments to Crown Land commoners:

Cattle £100
Registered pure bred New Forest ponies £80
Other equines £40
Pigs £30

There is a maximum payment of £6,000.

We set the rate for a Livestock Unit at £100, for several reasons. Firstly we want to make sure that no one who voluntarily reduced their turn-out of cattle under the old Countryside Stewardship Scheme loses out financially. Secondly we would like to build a buffer against future increases of marking fees which are an inevitable consequence of the current necessary government reduction in public spending. And thirdly, we are following Natural England's wish to encourage more cattle grazing the Crown Lands, because cattle graze in a different way to ponies, giving enhanced environmental benefit to our beautiful New Forest.

When introducing the new VGS, I had promised that the payment made for a registered pure bred New Forest pony would be at least as much if not more than the previous £70 payment under the old Countryside Stewardship Scheme. So the new level of £80 for a registered pure bred New Forest pony will be nearly 15% higher.

Payments will be made in the Spring of 2013.

May I remind commoners that the pot of money will now be fixed at the total based on the current turn-out at these Livestock Unit payment rates. If the total number of animals depastured increased, this will therefore result in a pro-rata decrease in the value of the Livestock Unit, so commoners will receive less grazing payment per animal. This is designed to stop a huge increase in animals turned out simply to claim the subsidy.

We are asking the Verderers Grazing Scheme Advisory Group to recommend rates for the Adjacent Commons. The key decision makers on this forum include the National Trust, Natural England, and representatives of commoners who depasture on the Adjacent Commons.

# **ANIMAL ACCIDENT REPORT**

# 2012/6334 ACCIDENT REPORT FOR OCTOBER 2012

The agisters attended 15 accidents compared with 17 in October last year.

6 ponies were killed.

2 ponies and 1 cow were injured.

1 pony was uninjured.

4 ponies and a cow which were reportedly involved in accidents were not found.

All bar 1 accident occured in the dark.

The total killed and injured this year to the end of October was 59, compared with 76 in the same period last year.

October's accidents were spread throughout the Forest with a number of roads involved including, as usual, the B3078 and B3079 from Brook in the north and the B3054 Lymington to Beaulieu and across to Dibden in the south.

The beginning of November has been particularly bad for accidents with 24 occurring

between the 1st and 17th of the month. 6 ponies have been killed and 3 ponies and a cow injured. 2 of the ponies which were killed were wearing collars. 7 animals escaped without injury and a further 7 have not been found following reports that animals had been hit.

This compares with 17 accidents for the same period last year in which 4 animals were killed and 2 injured.

This is typical of this time of year, just after the clocks change. All bar one of the accidents occured in the dark and we can only assume that drivers are failing to adjust to driving across the Forest in the dark.

# 2012/6335 SHEEP ON THE FOREST AND COMMONS

Presentment by Mr Geordie Cook

Mr Cook again raised the issue of sheep on the Forest and Commons. He produced some papers for the Court to consider. Mr Cook continues to believe that the presence of sheep on the common and Forest in the Bramshaw area is illegal and he said he proposes to take the matter further. He went onto say that he considers that previous statements made by the Court are inaccurate. He said that the Court has never explained why it believes sheep should be allowed on the common and added that in his opinion it has nothing to do with the National Trust.

Unfortunately, despite a request for clarification from the Official Verderer, the Court was unable to obtain confirmation of precisely who Mr Cook intends to progress the matter with. Mr Cook mentioned the District Surveyor and then Her Majesty the Queen.

### 2012/6336 MAXIMUM AGE FOR ELECTED VERDERERS

# 2012/6337 QUEEN ELIZABETH II DIAMOND JUBILEE RIDE 2012

Presentment by Mr Richard Deacon on behalf of the New Forest Commoners' Defence Association (CDA)

On behalf of the CDA, it is my pleasure to be able to present the Verderers' Court with our initial version of a wall display, commemorating the CDA's Queen Elizabeth II Diamond Jubilee Ride, which was run over some 74 miles close to the boundary of the Crown Lands of the Forest, in August 2012.

We anticipate there will be several iterations of this display before we arrive at a suitable permanent form, which I can explain as follows:

All the participants of the Jubilee Ride are entitled to receive a Jubilee rosette together with their own copy of Her Majesty's message of support read out at the commencement of each stage of the Ride. The rosette and the message are part of the display temporarily placed in the cabinet to my right.

The first distribution of these rosettes will take place at the annual Point to Point meeting on Boxing Day, where the Ride participants are invited to claim their memento in return for their signature on the Roll of Honour, which when complete will be bound and lodged

with the display in the Court archive.

Those unable to make the Point to Point will have a further opportunity to claim their rosette at the CDA AGM in March.

The present version of the display is in need of one or two further photographs recording activity out on the Ride, which I hope will come to light at these two opportunities.

Ultimately, it is the CDA's hope that the Elizabeth II exhibit will complement that of the Charles II Coat of Arms mounted above our Official Verderers seat. We envisage a glass fronted, oak framed, hexagonal enclosure, possibly mounted on the wall immediately behind me above the Agisters seats.

# NEW SUBMISSIONS AND OTHER MATTERS RAISED BY THE FORESTRY COMMISSION

2012/6349 SOUTHERN GAS NETWORKS – NEW DOMESTIC CONNECTION TO DISCHARGE BRANDY COTTAGE, SWAY

The proposal to provide a new underground gas supply service to this property was approved subject to the standard three conditions of safe working conditions, satisfactory re-instatement and compensation for loss of grazing.

# 2012/6350 FISH AND CHIP TRADING - CROWN LANDS NOMANSLAND

DISCHARGE

Mr Street explained that this matter has arisen as a result of the local Keeper moving on a pizza van. In order to be consistent, he then also spoke to the fish and chip trader who regularly parks on Forestry Commission land at Nomansland for up to two hours. Investigations revealed that the latter has been trading in the area for a considerable length of time although the present proprietor only took over the van four or five years ago. There is considerable local support for the facility.

Action MStr

After careful consideration the Court agreed to consent to the Forestry Commission issuing a licence for this particular van but stressed that this must not set a precedent.

The Forestry Commission agreed that a licence for a maximum term of three years will be issued with strict conditions which will include the trader being responsible for ensuring that all litter is cleared within a specified distance of the van as happens with the ice cream salesmen at present and that he complies fully with all relevant environmental health regulations. Evidence of the latter will be required.

It was pointed out that there are issues connected with this particular trader relating to the property from where he is running his business. The Forestry Commission confirmed that it is carefully monitoring the impact of the business on the Open Forest outside the property at Bramshaw Telegraph.

Another fish and chip van is known to visit East Boldre but that van does not remain static and moves through the village. For that reason it was agreed a formal consent is not required at present.

# MATTERS ARISING FROM THE MINUTES OF THE LAST COURT AND PREVIOUS COURTS OF CONCERN TO THE FORESTRY COMMISSION

# 2012/6351 ICE CREAM TRADING

RESUME October 2013

The Court's request for the ice cream vans at Hatchet Pond and Stony Cross to be re-sited on grounds of health and safety of the public and commoners' stock was discussed further. The Forestry Commission stated that it would prefer the vans remain in their current positions, which they have occupied for more than a decade, apparently without incident.

The Deputy Surveyor said he understands the Court's additional concern about the damage to the verges which is being caused at the Hatchet Pond location and he said he is happy to reinforce the car free ditching and dragons teeth to try to resolve the problem of verge parking. The Deputy Surveyor then advised that the Licences and Verderers' Consent are in fact out of sync. The consent given by the Verderers expires in December this year but the Licences are not due for renewal until next

year.

It was, therefore, agreed that the Verderers' consent will be extended by one year and in that period the Forestry Commission will undertake the work required to protect the verges at Hatchet Pond and will also give further consideration to the re-siting into the adjacent car park of the van at Stony Cross which is currently alongside the road.

# 2012/6352 CROWN LANDS CYCLE NETWORK

**DISCHARGE** 

The Deputy Surveyor reported that the installation of the new posts and signage is complete. No signs have been removed and therefore if some 'no cycling' signs are missing it is most likely that they were on separate posts which have fallen into disrepair. Unfortunately the Forestry Commission does not have the positions of the old signs plotted digitally on a map although the new ones are.

Mr Pasmore insisted that several signs at major junctions on the cycle network are missing. These signs indicate to cyclists where they are not supposed to go, whilst also directing them onto the network. Hampton Ridge and Pitts Wood were given as examples as well as Old House.

The Deputy Surveyor went on to say that he is happy to reinstate any no cycling signs that are missing and suggested members of the Court should let their Clerk have a list of locations.

Action MS Verderers SW

The Deputy Surveyor went on to say that the cycle counters are being installed now. He apologised that they are a year late. There will be 10 counters, 5 on the network and 5 off it. He went on to report that since April this year, 600 maps have been given out free of charge by the Ranger Team. Only about 80 maps were actually sold through the Forestry Commission. There are also various other outlets for the maps. A stock of about 8,000 maps has been obtained for next season.

Acting Deputy Surveyor, Mr Kevin Penfold, wrote to all Forestry Commission field staff in April 2012 reminding them of the Forestry Commission's policy on cycling and instructing them to engage with the cycling public to police, support and promote responsible cycling. Mr Pasmore suggested that more effort needs to be put into targeting young men who charge about on the open heathland. He referred to a magazine article which had appeared in the past inviting readers to visit the New Forest as the place to come for 'muddy good fun'. The Deputy Surveyor confirmed that the Forestry Commission does not condone such activity in the New Forest and explained it does have other sites outside the New Forest where such activity is permitted and appropriate. He added if cyclists are abusing the Forest the locations will be targeted although resources are limited.

The Court finally agreed, with some reluctance to the renewal of the consent for the network of way-marked cycle routes within the Crown Lands for another three years, i.e. calendar years 2013, 2014 and 2015. The consent is, however, conditional on the missing 'no cycling' signs being replaced and to the Deputy Surveyor using his best endeavours to control illegal cycling, within the resources available to him.

# ANY OTHER BUSINESS OF CONCERN TO THE FORESTRY COMMISSION

#### SWAY MEMORIAL RECREATION GROUND, PITMORE LANE 2012/6366

DISCHARGE

The Verderers remain of the view that the fence which surrounds the Memorial Ground must be removed. Unfortunately there is a long history of the fence being poorly maintained and at times vandalised. The result is that it has frequently become a hazard to the commoners' animals which graze in the locality. Allowing the gorse to overgrow the fence can actually create a problem as it is then impossible to maintain the fence which inevitably falls into disrepair, resulting in loose wire which is very dangerous.

The Verderer's consent for the renewal of the licence will therefore, be conditional on the removal of the fence and all traces of the pavilion including any hardstanding, pipes or electrical connections etc. The Verderers will visit the site at the time that the licence renewal application is received.

Several other sports fields including those at Shobley and Burley operate without a fence. It was noted that the pavilion at Sway has now been demolished and that was welcomed by the Court. The Clerk will respond to the letter which she has received from the Parish Council, advising it of the Court's position.

### B3054 BEAULIEU ROAD, BULL HILL / NORLEY WOOD CROSSROADS DISCHARGE 2012/6367 HHW CASUALTY REDUCTION SCHEME

The scheme involves works which will not impinge on the verges and only sufficient signs as are necessary to make the scheme safe and effective will be erected, the Court raised no objections to the proposals.

RENEWAL OF FC WATER SUPPLY PIPE AT ALLUM GREEN (GR DISCHARGE SU278070)

The Court was content with the assurances received that the laying of the water pipe will not interfere with the old Duke of Bolton's cut walk and will not therefore damage the archaeology in the area.

#### NO RIDING SIGN OUTSIDE LITTLE HAY, BURLEY 2012/6369

Miss Macnair pointed out that the no riding sign on the gravel track which has resulted in riders riding on and damaging the adjacent grass has still not been removed even though it is not an approved sign. The grass has now been all but destroyed and Miss Macnair asked the Forestry Commission to please arrange for the removal of the sign. Mr Street promised to pursue it.

#### 2012/6370 NATIONAL GRID MAINTENANCE WORK, DIBDEN

A great deal of totally unacceptable damage has been caused by contractors working on the overhead power lines and pylons which traverse the Open Forest adjacent to the A326. Email correspondence between Mr Street and National Grid has been copied to the Clerk, together with photographs showing the damage caused by tracked vehicles which have been driven across the Open Forest in the recent very wet weather.

Mr Street has issued a 'stop notice' and Natural England has also been

> informed of the damage to the SSSI. Mr Street has advised National Grid that full re-instatement must be undertaken together with the payment of compensation for loss of grazing.

In addition, it is understood that a gate onto the A326 was left open, presumably by the contractors.

Mr Street said that it is most unfortunate that the earlier part of the works were undertaken without problems but it has all fallen apart now that a different team are working on the tower (pylon) protection.

#### REMOVAL OF ANIMALS FROM INCLOSURES 2012/6371

**DISCHARGE** 

Mr Deakin commented that a recent request for assistance with removing commoners' animals from inclosures was phrased in a tone which implied the Agisters do not help. In fact, the Agisters are happy to help, providing they are given adequate notice.

#### **FALLEN TREES** 2012/6372

**DISCHARGE** 

Mr Deakin said that whilst it is understood that it is not always possible for fallen trees to be removed immediately, he asked that they be made safe as soon as possible by removing a few limbs which could otherwise result in animals becoming trapped in the head of the fallen tree. Several ponies have died in recent years as a result of being trapped and in one case a mare was found still alive having fallen over and broken several legs. The Deputy Surveyor said he understands the concerns but he asked if when a tree is reported, it could be made clear if it is felt to be a hazard to stock.

#### 2012/6373 **VERGE CUTTING**

DISCHARGE

Mr Gerrelli asked if the verges could be cut back 1 chain from the road as was the previous custom and practise, particularly on the C10 on the east side of Burley, roughly where it passes the Golf Course. A couple of accidents have occurred there recently and a few years ago a driver successfully avoided having to compensate a commoner for the loss of his pony after a Court accepted that the pony had appeared without warning from behind a gorse bush which was very close to the road.

# 2012/6376 ROCKFORD FARM

A private individual has purchased Lots 1 and 2 and it is thought that land too may be available for back up grazing in due course.

### 2012/6377 POUND MAINTENANCE

**DISCHARGE** 

The Court confirmed that the £3,750 shown in the budget against pound maintenance is available for the current year 2012/13. (See formal Budget approval Minute 2012/6380 below).

### 2012/6378 NORTHERN COMMONS CONDITION ASSESSMENT

**DISCHARGE** 

A discussion took place on whether or not the Northern Commons are in fact overgrazed.

Mrs Westerhoff said that the commons pass the condition assessment that Natural England has been undertaking.

Mr Pasmore wished to point out that there may be different interpretations of 'overgrazing'. Mr Dowsett joined Mr Pasmore in a recent inspection of the Commons. In Single Farm Payment cross compliance terms, the commons, or some of them, may be considered to be overgrazed. It is to be noted that in some places the heather has been all but wiped out by grazing pressure.

The VGS Management Committee has asked the Advisory Group to decide on the level of payment in respect of animals turned out on the commons – both Northern and Western. The Advisory Group is chaired by John Durnell of the Hampshire and Isle of Wight Wildlife Trust.

# 2012/6379 LETTER TO THE RPA - SINGLE FARM PAYMENT RULES

**RESUME** 

A rather incomplete response which does not address a number of important issues raised in the Official Verderer's letter to the Rural Payments Agency has been received.

Mr Gerrelli and Mr Pasmore expressed an interest in doing so. The meeting is to be held on 12<sup>th</sup> December at the NFU offices.

# **STAFF MATTERS (including the Staff Committee)**

**MYOTONIA** 2012/6387 DISCHARGE

> Myotonia is a hereditary muscular disease that had only been known in goats and dogs until this discovery. The disorder is characterised by increased muscular irritability and contraction with a decreased power of relaxation. If an affected foal is excited or startled, its muscles lock up suddenly, and they fall over and lie stiff for a few seconds. Ponies with myotonia cannot be used either as competition or recreation ponies, as even at rest they can display symptoms. They may have difficulty rising after a period of rest, a stiff and stilted gait when walking, and a bunnyhop movement when running. In addition there are increased respiratory sounds and difficulty in swallowing. In other words, these foals are basically useless. There is no known treatment available.

> In December 2011 the Dutch New Forest Pony Studbook Society informed the Society that two Dutch New Forest foals had been diagnosed with myotonia by the University of Utrecht. A specialised research laboratory in Switzerland had been asked to carry out hereditary testing and it was established that a hereditary defect was involved. Through DNA testing it was found that, in each case, both parents of the foals carried an abnormal or 'faulty' gene. It was noted that both foals were by a stallion descendant of Kantje's Ronaldo, and that this stallion also occurred in the dam lines.

> Mr Deakin advised the Court that the New Forest Pony Breeding and Cattle Society is proposing to test all breeding stallions for this disease.

> The Society has requested the assistance of the Verderers and Agisters in testing the stallions which are currently in the grazing at Cadland Manor. The Court confirmed it is pleased to assist.
